

## **KBAK/KBFX DISNEYLAND® CALL IN CONTEST**

### **Who Can Enter**

1. To be eligible to participate in this contest, entrants must be California residents who are 18 years of age or older and reside in the KBAK/KBFX viewing area.
2. Employees of Sinclair Broadcast Group, Inc., Sinclair Television Group, Inc., Sinclair Television Media, Inc., and any other company which owns, programs or provides other services to television broadcast station KBAK/KBFX (collectively the "Station"), Disneyland® Resort in California, The Walt Disney Company, their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, contest software providers, social media companies, and the immediate family members of each are ineligible. The term "immediate family" includes spouses, grandparents, parents, siblings, children and grandchildren. Only one winner per household.

### **How to Enter**

- a) No purchase is necessary to enter. Qualified entrants may enter as often as they wish.
- b) From May 25, 2015, to June 5, 2015, viewers will be asked to call in on a designated telephone line at a particular time or times during the Eyewitness News program, which airs weekdays at 5:00 a.m. PDT on KBAK channel 29 and at 7:00 a.m. PDT on KBFX channel 58. At the time calls are solicited, the criteria for winning will be announced (e.g. first six callers, tenth caller, first caller with the correct answer).
- c) One or more contests may be announced from time to time. More than one contest may run simultaneously, but entries will only be solicited for one contest at a time. Station is not responsible for any telephone system failure or malfunctions or other inability of entrants to reach telephone entry line.
- d) Two (2) daily winners will be selected in accordance with the criteria announced when calls are solicited, for a total of twenty (20) winners. The contest will be judged by Station personnel, and the decisions of the judges will be final as to all matters, including (i) the order in which calls were received and (ii) whether any answer required to be given is correct
- e) By calling the designated telephone line, each contestant gives permission to Station to record and/or broadcast contestant's telephone call. All entries received from ineligible entrants will be void. All entries become the property of Sinclair Broadcast Group, Inc., Sinclair Television Group, Inc., and the Station. Poorly connected or disconnected cellular phone calls may be disqualified. Calls for contestants are taken in order of receipt. In the event that more than one voice is heard on the phone line, the contestant/qualifier or winner will be the first person to speak. If the judge(s) is not able to determine which caller was first, a random drawing will be held to determine the winner. The use of switching or programming equipment by telephone company employees is in violation of contest rules and is not permitted. Due to any time delay between a station's over-the-air signal and the station's online webcast or

streaming, viewers who watch the station's online stream may hear a cue to call later than viewers watching the over-the-air signal. As a result, the odds of an online/mobile viewer being able to enter or become a winner may be diminished.

### **The Prize(s)**

1. Twenty (20) winners will be selected. Each winner will receive four (4) tickets to Disneyland® Resort in California, valid for admission on one (1) day to one (1) park; Disneyland Park or Disneyland California Adventure. Each prize package is valued at \$384. Tickets are subject to the terms and conditions of the prize provider, including any restrictions, and must be used by December 15, 2015. Station and prize provider are not responsible in the event a park is closed for maintenance or weather conditions.
2. Each winner will be notified at the time of his/her call. Before claiming any prize, each winner must provide his/her correct name, address and telephone number to Station at the time of notification. Each winner must sign and return a release and affidavit of eligibility, which must be received within five (5) business days of notification, at the time winner claims his/her prize in person at the Station. Each winner must show government-issued photo identification to claim a prize. Station reserves the right to examine additional identification and may choose to accept or deny awarding the prize based on the identification presented.
3. If a winner does not timely sign and return the release and affidavit of eligibility, then the prize will be forfeited, an alternate winner will not be selected, and the prize will remain the property of the Station.
